2025 iTax Ledger Reconciliation

The Kenya Revenue Authority's ("KRA") online services portal, iTax, provides taxpayers with a one-stop general ledger that summarises an entity's historical and current transactions with the revenue authority, including details of tax returns filed and payments made.

Through experience, we have observed that taxpayers may unknowingly be having outstanding liabilities on their iTax profile that exposes them to penalties and continue to accrue significant amounts of interest, have erroneous liabilities which may delay the issuance of a Tax Compliance Certificate and have tax refunds that could be used to offset current or future tax liabilities.

We should be pleased to carry out a high-level review of your iTax ledger and advise you thereafter on the overall health of the company's compliance record with the KRA. Based on the outcome of the analysis, we will discuss whether a detailed analysis will be required for the entire iTax ledger or on specific tax heads. The detailed analysis will seek to ascertain the full extent and implications of the issues or gaps identified, as well as devise corrective and mitigating measures.



Transfer Pricing Documentation Standards

Effective 1 July 2022, Kenya introduced Transfer Pricing documentation standards for subsidiaries and branches of Multinational Enterprise (MNE) Groups that have a consolidated turnover of over KES 95 billion (approximately EUR 750 million).

The entities that fall within the above threshold will need to file the following documents with the KRA:

- 1. Country by Country ("CbC") report not later than twelve (12) months after the last day of the reporting financial year of the MNE group.
- 2. **Group Master File** not later than six (6) months after the last day of the reporting financial year of the MNE group.
- Local File not later than six (6) months after the last day of the reporting financial year of the MNE group.
- 4. **CbC Notification** not later than the last day of the reporting financial year of the MNE group.

Taxpayers with foreign intercompany transactions but do not meet the threshold will continue to comply with the Transfer Pricing documentation obligations under the Kenya Income Tax (Transfer Pricing) Rules, 2006 ("Kenyan TP Rules").

There is no annual filing requirement, but taxpayers are required to prepare and submit transfer pricing documents to KRA upon request.
