Highlights from the Conference

Panel discussions on investments and access to finance

All panels were structured as interactive sessions, with attendees given ample opportunity to ask questions and share their thoughts on the topics being discussed.

Panelists were experienced investors, startup founders, and ecosystem builders (11 Venture Capital, Vitosha Venture Partners, South Central Ventures, Driton Musoli - Angel investor @ Keiretsu Forum SEE) who shared their perspectives on the challenges and opportunities for investment in the Macedonian startup ecosystem.

Representatives from the Swiss Increasing Market Employability Programme (IME) shared more information on the options for access to finance for startups.

Attendees could more about the opportunities for startups in accessing capital and the role of government and international investors in supporting the ecosystem.

Bio-Hack My World: Launch by UNDP

Panelists from UNDP, UNICEF and experts from the technology, sustainability and waste management field shared their insights on the challenges of waste management and the potential for technology to help solve these challenges.

Panelists introduced the newly opened Laboratory for development of biotechnology established under the Faculty of Technology and Metallurgy supported by UNDP as part of the Project Bio-Hack My World and shared more details on the options for startups to use the laboratory in developing innovative solutions for reducing waste and repurposing waste materials.

Accelerators as a link between ideas and investment

This session included panelists from GIZ EU4EG project, Business Accelerator UKIM and Impala.

Panelists shared successful stories and outlined the important role of accelerators to provide investors with a pipeline of high-quality startups that have been vetted and prepared for investment. Attendees had opportunity ask questions on the range of benefits, including access to expertise, resources, and funding accelerators can provide.

All workshops were organized in an interactive and engaging format that encouraged participation from attendees.

Each workshop included presentations, case studies, and hands-on exercises that allowed attendees to apply what they learned in a practical way.




