Vendor Due Diligence (VDD)

typically consists of a comprehensive assessment of a business to be sold, commissioned by the vendor at the beginning of a sale process.

is commissioned by a potential buyer of a business. It can therefore take place at various stage of the deal cycle.

Scope and focus can vary greatly, depending, for instance, on whether the vendor has provided a VDD report, or whether access is given to the business and its management team.
