



Feasibility study of the start of construction

- Legal analysis of city planning documentation in terms of legality of current location and parameters of the Object (in particular its designation/purposes use, area etc.), identification of potential risks, advise as to their minimization
- □ Cultural heritage check (Object and/or land plot, protection zones etc.), identification of potential risks, advise as to their minimization
- Legal analysis of investment structure into the Object; further optimization thereof
- Review of presence of any encumbrances, third party's rights with respect to the Object and underlying land plot, identification of potential risks, advise as to their minimization
- □ Legal analysis of the terms and conditions of the Construction contract from the prospective of optimal Object construction and commissioning, compliance with legal and regulatory requirements, Client's interests; identification of doubtful provisions (in light of the above), and vice as to their elimination and amendment



Control must be ensured both during and after construction. Our specialists will carry out a project implementation analysis, including a review of actual delivery against the scope and cost of work to identify any differences with incurred expenses. They will also review contractor selection procedures to identify affiliated companies and estimate potential damages.

- Legal check of compliance with licensing and other regulatory requirements of the general contractor (other contractors/subcontractors)
- Legal analysis of project and permissive documentation obtained up to the current stage of construction in terms of its completion, fulfilment of legal requirements etc.; identification of the most crucial legal defects/omissions, which might affect further constriction, commissioning and operation of the Object
- Analysis of the degree of readiness of facilities under construction
- Monitoring of documents confirming expenses actually incurred by the contractor and billed for payment to the customer
- Analysis of the contractor's reporting to the customer for correctness, completeness and consistency
- Visual analysis of the work performed for compliance with design and normative-technical documentation
- Analysis of accounting and elimination of orders of supervisory authorities
- Legal due diligence of the Object and underlying land plot, rights of the developer/third parties thereto, identification of potential risks, advise as to their minimization
- Review of technical documents on commissioning of the Object in accordance with Ukrainian law, identification of potential risks, advise as to their minimization


